4. Details of our assessment

This assessment is being carried out on the 15th July 2025

DCWW notified NRW on the 17th June (for suspended solids result) and the 20th June (for BOD result) regarding the OSM sample taken on the 12th June 2025.

Both results were exceedances (within the allowable number of exceedances using the look up table) and not failures.

DCWW provided comments on the 14th July as follows -

The operator attended the 11th and 13th June and reported a turbidity of 30 (in comparison

to the samplers 90 on the 12th) on both occasions. The only thing that stands out on the trends is a sharp increase in flow caused by rainfall reducing settlement in the humus tanks. Flow peaks at nearly 3 l/s when site FPF is 1.7 l/s. Given the pro-longed dry spell preceding this downpour we think a short-lived deterioration occurred.
