This caused the site to spill sewage that had not gone through secondary treatment for a total of around 2 hours and 41 minutes. Please ensure this incident does not occur again and any crews carrying out maintenance are aware of what settings the pumps need to be left on.	31/08/2025

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

CARS form generated following self report from Dwr Cymru regarding a spill of untreated sewage from the Bronaber sewage treatment works on the 09/07/25.

Following a well clean at the site, pumps were left in the "hand" position instead of the "auto" position. This caused the site to spill untreated sewage into the Afon Eden for a total of around 2 hours and 41 minutes.

The site started spilling at 15:59pm and stopped spilling at 18:31pm when the site operator got to the site following an inlet overflow alarm and realised the pumps had been left on.

No visual impact at the spill location the following day. No samples taken to show no impact on watercourse. This lack of evidence makes it hard to determine the impact at the time of the spill as there are no photos or samples to support that the spill had no impact.

We are issuing a CAT 3 CARS with advice and guidance for this incident. Please ensure that any crews carrying out maintenance at the site are aware of the controls for the pumps so that this incident does not occur again.
