4. Details of our assessment

Natural Resources Wales Senior Industry and Waste Regulation Officers Rick Prichard and Carter Shone visited St Asaph Infra Red, Qioptiq Limited, Glascoed Road, St Asaph, Denbighshire, LL17 0LL at 10:00 on the 7th July 2025. This was an announced inspection as part of a site familiarization and handover.

The site

The officers were given an in depth tour of the site including all of the permitted emission points and shown the segregated waste systems.

No major issues were identified during the inspection, although a sub surface tank serving the skip area drainage was full and overtopping the drain, indicated by a small pool of water based coolant/water mix. Waste contractors were due to empty the tanks shortly. We discussed the possibility of erecting a roof to prevent surface water run off adding unduly to the tanks, but staff said there was to be a review of waste and other storage on site which may result in a tailor made solution. While we are in a period of low rainfall currently, regular monitoring of the tanks will help in the short term until a long term solution can be found.
