Tower Colliery Western Overflow (AN0314803)

Site Report

10:00AM

A compliance visit to inspect the Western Overflow at Tower Colliery (AN0314803) was planned for 10/07/2025. A Natural Resources Wales (NRW) Environment Officer, Senior Officer and Environment Team Leader were in attendance along with a Tower Regeneration Limited (TRL) operator. The weather was dry and hot with very little rain over the week prior.

We were informed by the operator that they were unaware of any discharge from this location and that if one was previously in place they believe it is no longer in operation. The discharge location (SN 9443 0538) was not checked on this occasion and other site permits were inspected on the day (AN0314801, AF3032201 and VP3722GM).

When checking the discharge location for AN0314801 it was apparent that a water outfall pipe was in place which appears to be originating from the direction of the western overflow (*photograph 1*). When checking GIS mapping this is also indicated the outfall may be connected with the discharge location on the permit. The TRL operator stated that they believed the pipe was for drainage of adjacent land which is not part of or owned by Tower Colliery. No discharge from the pipe was seen in our visit and we are not aware of any recent incidents from this outfall.
