4. Details of our assessment

Routine inspection of Asset. The weather conditions were dry and sunny at the time of the inspection.

The site is a Wastewater Treatment Works that processes sewage effluent. The permit (BN0020802) for the site is for the discharge of secondary treated sewage effluent to the Afon Teifi.

Officers were taken through the works from inlet, through the treatment system, and the final effluent sampling station. Officers were unable to check the outfall due to access issues.

Records checked (random selection) on site from log book. No ongoing issues identified.

The Process

Effluent enters the site at the inlet. There is a permitted Emergency overflow at the inlet of the works (BN0020801), however this appears to be operating as a storm overflow. This will be covered by a separate CAR Form.

The site consists of a primary tank, followed by treatment via a filter bed. The arm on the filter bed was moving freely and there did not appear to be any issues with pooling and excessive vegetation on the media in the beds. There was bi-carbonate on the filter beds to help balance the pH of the effluent at the time of the inspection. The effluent then enters the final settlement tank before discharging to the environment.
