4. Details of our assessment

Routine inspection of Asset. The weather conditions were dry and sunny at the time of the inspection.

The site is a Wastewater Treatment Works that processes sewage effluent. The permit (BP0164601) for the site is for the discharge of secondary treated sewage effluent and Discharge of Storm Sewage to the Afon Sawdde.

Officers were taken through the works from inlet, through the treatment system, and the final effluent sampling station. Officers didn't check the discharge point to the Afon Sawdde due to access issues, but there did not appear to be any evidence of fungus in the final effluent sampling point, however there was no flow at the final point and there was a flow entering the works, so there might be an leak under the filter bed that officers are not able to see..

Records checked (random selection) on site from log book. No ongoing issues identified.

The Process

Effluent enters the site at the inlet, there is no screen at on the inlet, solids settle behind a baffle in the primary/Septic tank before entering into the filter bed. The arm on the filter bed was moving freely and there did not appear to be any issues with pooling and excessive vegetation on the media in the beds.

Permit breach

Condition 2 The discharge shall be made in the manner and at the place specified as follows; via: pipe, to: Afon Sawdde, at OS Grid ref: SN7538 2411.

There was sewage leaking out of the brickwork on the sides of the primary/septic tank and pooling on the ground. It was discussed at the time of the inspection that the source of this leak needs investigation and repairing prevent further discharges to the ground.
