### 4. Details of our assessment

Previous CAR form CAR\_NRW0042801 queried whether there was a storm overflow at the site. (At that time there was a separate permit in place for storm overflow, however since 29/2/24, this has been consolidated into this permit).

Subsequent investigations have since occurred on site and DCWW have confirmed the following -

We have concluded our investigation at Rhydymwyn Wastewater Treatment Works, and have thoroughly assessed the potential for storm overflow. We exposed the chamber suspected of being a storm overflow discharge point, which contained two lines: a 4-inch

French drain running along the boundary of the works and another line that was bunged off, suspected to be a potential storm overflow.

We conducted jetting and CCTV inspections of the bunged line, which led us to a dead end, confirming that there is no flow path for discharge. Additionally, we jetted and carried out CCTV of the line in the inlet well where the EDM instrument is installed. The inspection revealed that water was not draining effectively, and the camera could not advance further up the line.

Based on these findings, we conclude that there is no storm discharge point from the treatment works, and no overflow is present.

This was re-confirmed at the recent DCWW/NRW liaison meeting in June 2025 with DCWW confident that there is no overflow present at this site. At this meeting it was agreed that DCWW will remove it from the overflow map and permit to be updated to reflect site operations.
