The purpose of the compliance assessment report (CAR) is to review the biannual reporting received by NRW on 14th July 2025.

Emissions to sewer

The emissions to sewer reports for the periods January to March and April to June 2025 were reviewed. All results were within the specified emission limit values (ELVs).

Permit condition 2.2.8.1 requires tanks T1, T2, T5 and T13 to comply with the parameters specified in table 2.2.11.

The Q1 and Q2 results show compliance with the parameters specified in Table 2.2.11.

Fugitive Emissions report 2024

The annual fugitive emissions report was received on 25th March 2025 in line with permit condition 4.1.4. No fugitive emissions are reported for 2024. As a preventative measure, new drainage to the interceptor tank has been installed around the various swarf skips on hard standing.
