The Waste report for quarter two (April to June 2025) was received on the 15th July 2025. A total of 10.8885 tonnes of EWC code 140601 was received during this quarter.

The reports were received within the time frame specified in permit condition 4.2.5.

The waste received is coded 140601 which is a code included in table S2.1.
