4. Details of our assessment

This report details the site visit made on the 9th July 2025 to Oliver's Skips Sales & Rental, Tir-y-Berth, Pengam - Permit number EPR-WP3799FB. NRW Officers Carla CURTIS and Mark O'GORMAN attended site for an unannounced routine site inspection at around 11:00. Officers met with the site Manager, Mr. Roger JONES who accompanied Officers around the permitted area. The weather conditions were warm and sunny at the time of visit.

GENERAL OBSERVATIONS

The Oliver's Skips Sales and Rentals site is used as a waste transfer station with treatment prior to waste being distributed to other companies / sites within the UK. The site was operational at the time of the visit. There were no offensive odours and / or excessive noise or dust at the time of the inspection.

During the site inspection, officers checked previous actions had been completed. Officers checked the skip storage area, located outside the permitted boundary and observed one skip containing broken UPVC window frames. Mr. JONES advised that it was placed there ready to be collected but had just been cancelled.

Permit condition 2.2.1 states: The activities shall not extend beyond the site. This is being scored Category 3 breach under W2A Permitted Activity

TECHNICAL COMPETENCY

The site TCM (Technically Competent Manager) is Roger JONES, WAMITAB certificate expires 14 January 2027.

WASTE RETURNS

Roger JONES is responsible for submitting waste returns for the site. The maximum total quantity of waste accepted at the site per year shall not exceed 30,000 tonnes. Based on the submitted waste return data for the last four quarters of 2024/2025, the total waste accepted was 7,300 tonnes which is well within the site's annual threshold. Please continue to submit these in line with your permit. Also please note, the deadline (as indicated in the below table) for waste return data for quarter 2, 2025 is to be submitted no later than 31st July 2025.
