4. Details of our assessment

Thankyou for showing my colleague and I around your facility on 9th July 2025. Generally the facility seems to be very tidy and well run, and the audit of the paperwork and records which the permit requires you to keep are clearly in excellent order.

The only issue which I identified was the absence of Waste Transfer Notes for the chicken manure going off-site. You have comprehensive records showing the dates, quantities and destination of the manure however you were unable to show me Waste Transfer Notes from the receiving AD plant. You have shown me e-mails proving that you have contacted them requesting that they provide the outstanding paperwork, knowing that we would be requesting sight of it during the inspection.
