4. Details of our assessment

This compliance assessment report has been raised due to Natural resources Wales senior industry and waste regulation officer Carter Shone carrying out and announced site inspection at the Eastman (Solutia) site on the 22/04/25 at 1000.

(IR2A) Permitted activities

The officer was shown around the permitted area of the site which appear tidy and well maintained.

No non-compliances were identified.

The officer was also shown the stormwater ponds just outside the permitted area, which have now become a haven for local wildlife, and was impressed with a care taken to maintain this habitat.

(IR3E) Monitoring

The operator was able to find a testing facility for MMCD (Methyl Morpholine-4-Carbodithioate). This issue was noted in CAR_NRW0046037. After reviewing this requirement for testing, the operator would still like to look into removing it from their permit, and are currently in discussion with their NRW officer to find the best way to do this.
