4. Details of our assessment

On Tuesday 15th July 2025, Natural Resources Wales received reports that suggested flies were causing a nuisance at a nearby sensitive receptor and that flies were potentially emanating from AMG Resources Ltd.

On Friday 18th July 2025, in response to these reports, Natural Resources Wales investigated this incident. As part of the investigation, the local area was inspected for potential sources of flies.

An inspection of AMG Resources Ltd was undertaken as part of the investigation of this incident. The following observations were made:

Incident Response

Natural Resources Wales assessed operating procedures on site to be compliant with the requirements of the site Pest Management Plans.

Specific points of observation:

- General housekeeping on site has improved in recent months. Areas behind walls, in corners of the site (inside concrete A-Frames specifically) appear to be cleaned regularly. Levels of wind-blown litter around the site have decreased.
- Fencing with netting has been erected around operational areas to further prevent litter escaping operational areas.
- While on site, we inspected one load of waste that was being accepted on site at that time. Pre-acceptance checks for loads was discussed. It was also noted work was ongoing with waste producers regarding management of waste prior to its arrival at site.
- Flies were witnessed in the baled waste which was yet to be processed. It was agreed additional monitoring and treatments (sprays) would be undertaken to assist with the mitigation of flies.

On this occasion, a link was not established between flies on site and flies at a nearby sensitive receptor. Operations were assessed as being compliant with the Pest Management Plan for the site.
