CARS form generated following site visit to Aberllefenni sewage treatment works on the 23/07/25.

Natural Resources Wales environmental officer for Meirionnydd and Dwyfor met with the performance manager, operations supervisor, pollution tech and the senior operations officer at the site.

The inlet and primary tank were inspected. Following the primary tank the water is sent

through a reed bed and then out to the discharge point and into the Afon Dulas.

No access to discharge point. **For Action** Could Dwr Cymru create an access route to the discharge point so that it can be inspected in the future. Please complete this action by **31/10/25**.
