4. Details of our assessment

Myself and Rob Harding attended site on an un-announced inspection on the 6th June. The weather was warm and dry with some rain showers in the previous few days. River levels were normal to low.

The turbine house was locked so we did not access the meter but the scheme was not operating at the time of the visit. The outfall appeared to be hanging out over the watercourse, this seems to be a result of river channel movement.

On arrival there was a large tree sitting across the top of the screen which made access difficult. This tree has pinned a large stone in place but this did not appear to be impacting the scheme adversely. However it could affect the intake in higher flows or damage the structure over time, I recommend this is investigated and removed as soon as practicable. The HOF was flowing freely but was not measured during this inspection. The measurements of the scheme did not match the permit drawings however due to the nature of the scheme it is still compliant for flow.

ACTION: I recommend you clear the tree and stones during the lower summer flows and notify NRW once this has been done to enable a re-inspection.

Abstraction quantities were not assessed during this inspection and will be evaluated separately using Abstraction Returns.
