4. Details of our assessment

Overdue Improvement Condition – IC15

We are writing to formally notify you that **Improvement Condition 15 (IC15)**, as required under the above Environmental Permit, is overdue. **This has come to our attention when reviewing matters relating to Cell 17 following a request to consider restoration options for this part of the landfill.**

IC15 requires the submission of a report for written approval by Natural Resources Wales as shown below.

15	The Operator shall forward to Natural Resources Wales for written approval, a report to show how, in the event that Cell 16B or Cell 17 is not built or the compaction does not take place, as per variation application EPR/TP3435LA/V004, the management of the historical waste within the footprint of Cells 16B and 17 is to be undertaken. The report shall include the following as a minimum: • Extraction measures; • Landfill gas management; • Leachate management; • Groundwater monitoring; • How the site is to be re-profiled; • Surface water control and management; and • Capping measures; Should Cells 16B or 17 not be built, the Operator shall manage the impacts of the historical wastes within the footprint of Cells 16B and Cell 17 as per the agreed proposals to a timeframe to be agreed in writing by Natural Resources Wales. The Operator must implement the report as approved, and from the date stipulated by Natural Resources Wales.	30 November 2019 unless otherwise agreed in writing with Natural Resources Wales.

To date, no submission as required by the IC has been received. We therefore request that you submit the information as required no later than **31st October 2025**.

The submission may be in the form of a report, as outlined in the IC, or submitted as part of an application to vary the Environmental Permit. Enovert have previously stated the intention to submit a variation application in October 2025 and this has informed the deadline above.
