4. Details of our assessment

This Compliance Assessment Report (CAR) follows an unannounced inspection of Wrexham Transfer Station on the 15th July 2025. The SHEQ Lead and SHEQ Officer were on site for the visit.

The Site Manager and Plant Manager are still completing their WAMITAB Certificate of Technical Competence (CoTC) training. Officers reiterated their concern that there is no dedicated permanent onsite member of staff with CoTC qualifications at Wrexham and that the Operator is reliant on the SHEQ Lead to provide this function. The SHEQ Lead has booked their continuing competency assessment.

Officers inspected the recent kerbing and jointing work, the Operator explained that some joints were appearing to fail and that they were in contact with the Contractor to undertake remedial works.

The gates to the trailer parking area and staff car park have been installed.

The yard was tidy and well ordered. There were 4 bins in the quarantine bay, these were not all logged on the quarantine log within the control room. There were also bins documented in the quarantine log that had since been processed. The Shift Team Leader updated the log at the time to reflect those that had been processed. Further information was provided following the site visit for the two bins not on the quarantine log. **As the quarantine log had not been maintained this has been scored a category 3 breach against condition 4.1.1 - compliance criteria IR4A Records.**

Action 1: The Site Manager stated that a Toolbox Talk will be carried out with all shifts to ensure the quarantine process is being followed correctly and consistently.

Evidence of the Toolbox Talk and associated training records may be reviewed at future visits.
