4. Details of our assessment

Introduction

This Compliance Assessment Report (CAR) is regarding a Site Visit undertaken on the 15th of July 2025 by Natural Resources Wales (NRW) to the Pwllfawatkin Landfill Complex, which is managed by FCC Environment (the Operator) under permit number EPR/BU8819IV.

Scope

This was a pre-arranged visit, the purpose of which was to attend the fifth periodic progress meeting. Following completion of the restoration soils deployment on the 4th of July 2025, this visit acted as a closing meeting for the programme of works.

Representatives from the following companies/organisations were in attendance:

- FCC Environment
- Sirius Group
- Jones Bros Civil Engineering
- INFINIS Energy
- Natural Resources Wales (NRW)

Site Observations

The NRW Officer arrived onsite at 09:40 and were met by the representatives of the companies involved with the capping works. The key discussion points of the visit are summarised below:

- Restoration soils are no longer being imported into Pwllfawatkin Landfill Complex.
- Deployment of restoration soils over the entirety of Tip 890 has been completed.
- Area previously utilised for restoration soils stockpiling has been graded in order to promote drainage into the southern surface water lagoons.
- Spinal drainage lines associated with the surface water infrastructure have been completed.
- Jones Bros Civil Engineering due to depart from Site on the 18th of July 2025.
- Reconnection of the gas infrastructure associated with Tip 890 planned to commence on the 21st of July 2025.
- Remedial works on PWLMW4NB (see CAR_NRW0048422) proposed to commence on the 4th of August 2025 (weather permitting).
- Installation of four gas wells on the crest of Tip 890 (by INFINIS) proposed to commence on the 11th of August 2025 (weather permitting). Construction Quality Assurance (CQA) Plan (*Pwllfawatkin Gas Well Drilling CQA Plan Infinis June 2025*) approved by NRW on the 3rd of

July 2025.
