This Compliance Assessment Report (CAR) has been issued in response to the submission of the six monthly returns for emissions to water by The First Milk Cheese Company Ltd (First Milk) for activities at Haverfordwest Creamery, Pembroke Road, Merlins Bridge, Haverfordwest, SA61 1JN under permit number EPR/XP3830U.

Compliance Assessment

Table S4.1 (Schedule 4(b)) of the permit states that the 6 monthly reporting period for emissions to water begins on the 1 January and the 1 July respectively. Schedule 3(b) emissions and monitoring effective from 4 December 2023.

The 2025 6 monthly monitoring returns for Emission Point W2 were submitted to NRW by First Milk on the 25 July 2025 in compliance with permit condition 4.2.2.

The operator submitted the *Reporting emissions to water (other than sewer) and land for the period from 01/01/2025 to 30/06/2025* in the agreed reporting format (Form Number: Water 1 / 04/12/2024).
