4. Details of our assessment

I attended site on an un-announced inspection, the weather was warm and mostly dry following a dry few days. There was no one on site during the inspection so I was unable to fully inspect the site.

On entering the site I first observed a new sensor had been installed on the storm lagoon. The lagoon itself appears unchanged otherwise, levels were low and there was still reeds/rushes growing within.

By the main lagoon there was a slight odour detectable. The lagoon level was low with some of the air pipe-work being exposed above leachate level. There also appeared to have been some new pipe installed on the eastern end but it was unclear what purpose this served.

ACTION: Confirm purpose of new pipework structure.

The first reed bed had significant growth within making it difficult to see but it appeared the flow meter had been connected by the wet well.

ACTION: Confirm flow meter has been installed and is functioning correctly.

While on site I also identified what appears to be a stand of Japanese knotweed growing along the side of the footpath, to the south of the main lagoon. This may need further investigation to confirm and consider suitable actions to ensure it doesn't spread.
