4. Details of our assessment

The site was inspected by NRW Officers on the 16th July 2025 accompanied by DCWW catchment manager and Operations Supervisor.

The site was compliant with its permit with no non-compliances observed.

There was a back up power source for the filter bed distribution arm via solar panel which operated via a sensor on . It was good to see this initiative as the sensor on the filter bed would detect when there had been no movement from distribution arm within a specified period and kick start.

The bed of the final tank would benefit from being brushed to clear of growth. This was to

be done by the site operator as part of their maintenance checks on a weekly basis.
