Dear Mr Price

On 25th July 2025 a routine inspection was carried out to ascertain compliance with your Licence conditions.

I am pleased to say, at the time of the inspection you were compliant with licence conditions in that due to flow in the watercourse being low, no abstraction was taking place. On this occasion measurements of the structure were not taken.

Recommended action

Could you please ensure that the scheme is kept clear of any obstructions including overgrowth which may block the HoF notch and/or hinder fish passage.
