4. Details of our assessment

This Compliance Assessment Report (CAR) has been produced following an assessment of the operator's co-operation in the management of landfill gas at Docks Way landfill.

Context of the assessment

The assessment was undertaken following the operator and Novera Energy Generation No 2 Limited (the operator of Docksway Generation Plant EPR/LP3135SB/V003) making representations in regards to the continued co-operation in the extraction and combustion of landfill gas.

The assessment therefore draws on permit condition 2.12.3 in environmental permit EPR/LP3135SB which the operator is required to co-operate with.

Environmental permit EPR/LP3135SB condition 2.12.3 states:

2.12.3 Both Operators on the site shall co-operate to ensure the safe^[1] extraction and combustion of the landfill gas using the systems they have agreed and set out in the application.

In addition to the on site inspection, the operator provided the following information in support of the assessment:

Email, 02 July 2025, 08:51, from [Team Manager - Landfill] to Luke Burton.

The operator has demonstrated through the site inspection and referenced email that:

Both Operators on the site are co-operating to ensure the extraction and combustion of the landfill gas.

Note: The inspection was carried out on 27 May 2025, but further information required to make a full assessment of compliance following the inspection was provided on 02 July 2025. For the purposes of the Industrial Emissions Directive CARs can be issued 2 months following an inspection. Inspection in this sense is defined at the point at which all information required to make an assessment is provided.
