4. Details of our assessment

This compliance form is the result of a follow up visit to site on 04/07/2025.

Attended site at 10:00am and met with onsite staff. Went down to the site's treatment works and inspected final effluent chamber which looked to be in good condition. The site had also recently had a tanker in to empty out the excess solids within the treatment works.

NRW monitoring team were due to take samples later in the week.

The results of these samples were the following:

Suspended solids: **20mg/l** (limit: **60mg/l**)

Ammonia: **5.96mg/l** (limit: **20mg/l**)

BOD: **7.59mg/l** (limit: **40mg/l**)

Looking at the sample results on this occasion in comparison to the previous compliance form (CAR_NRW0048125 on 31/03/2025), it suggests that this sites failures are the result of the period in which it closes during the winter months and therefore has no flow through the treatment works.

A follow up call with site staff revealed that they intend on having permanent residences on site going forward which may help improve these failures during the winter months when there has historically been nobody on site, and therefore no flow.
