4. Details of our assessment

This was a pre-planned site visit carried out by Natural Resources Wales (NRW) officer Ffion Quan who was accompanied by the factory manager, Slawomir Sarna.

The process

Quay Fresh is a seafood processing factory, consisting of trade effluent discharge from shellfish processing. The shellfish is processed and cooked on site with liquid from the cooking process discharged via a pipe into New Quay Bay. The discharge pipe is not

accessible due to health and safety reasons therefore it wasn't inspected on the day of the visit. There is a sampling point located further up the discharge point at approximately SN 38718 60446. There is only flow discharged through the pipe whilst cooking is ongoing. There was no flow during the visit.

Organic waste from the cooking process is sent to the local waste management and recycling company and subsequently to a local anaerobic digester plant. The previous marine licence to discharge the whelk shells expired in August 2016 which was not renewed, however, the shells are now processed and sold by your sister company, Shell On Earth.

Inside the drainage channel at Quay Fresh is cleaned everyday as part of the everyday cleaning schedule on site and the cleaning of the entire discharge pipe is done once every 6 months using marine safe cleaning products.
