4. Details of our assessment

Natural Resources Wales senior industry and waste regulation officers Rick Prichard and Carter Shone visited Toyota on the 23rd July 2025. This was a pre-arranged familiarisation visit and site inspection accompanied by the Principal Engineer and various other members of staff with responsibilities within the site.

Permitted activity

NRW officers were given a full tour of the casting facility. The area was clean, tidy and well organised. The emission points for the activities were clearly designated with information available for all personnel, with a copy of the permit clearly marked and available. All emission points were well maintained. NRW officers were shown the changes proposed to the re-routing of emissions from the swarf melting process.

The site

NRW officers were given a full tour of the site, including the nature reserve, ponds, beehives and allotment which have been completed over the last few years and contribute greatly to local biodiversity.

Emissions to water

NRW officers were shown the penstock system for controlling surface water from the site. The system was well maintained and the opening/closing operation was demonstrated to be in good order.

Odour

No offsite odours were noted during the inspection.

Noise and vibration

Offsite noise was not deemed to be at all excessive.
