4. Details of our assessment

Routine site inspection, by Environment Officer Peter Jones, of the sewage treatment plant serving The Lamb and Flag Hotel, Abergavenny. The permit authorises the discharge of treated sewage to the Nant Iago at OS grid reference SO2815 1520. The volume discharged is limited to 13.4 m³s per day.

A visual inspection of the sewage treatment plant and effluent discharge point was completed, a sample of the discharge was not taken. The treatment plant looked to be operating as designed and the discharge was having no visual impact on the water course.

I noticed two of the locking mechanisms for the covers on the PTP was missing. It would

be worth asking your services engineers to replace the mechanism to prevent unauthorised access or rainwater ingress. I have attached a photograph for your information.



Please ensure the treatment plant is regularly serviced and de-sludged and follow the manufacturers recommendations to ensure the system continues to operate efficiently.
