Compliance Assessment Report – Convatec – EPR-NP3433BC and EPR-TP3535LH

Introduction

On the 30th May 2025 your site was inspected by officer Ian JAMES.

The site holds two permits as follows;

EPR-NP3433BC v005 – Unit 1: 4.5 A (1) (a), 7 Part B and DAAs inc. RTO

EPR-TP3535LH – Unit 2: 4.1 A1 (a) (viii) and DAAs

The visit was hosted by SHE Manager – Joel GOODCHILD

This report is duplicated across both permit records given that no breaches were identified for either and there are common systems and infrastructure.

Site inspection

Changes – JG gave an overview of site personnel changes and corporate targets and how these align with Permit conditions.

Construction to the south of the permitted facility was ongoing but no material effect to the existing Permits are anticipated. Site security and future access at the interface is acknowledged.

A discussion on Climate Change Adaptation was had and JG explained how this is being assessed internally as part of the requirements for their ISO accreditation and those detailed by NRW. An external consultant is involved in this and JG provided both CC Risk Assessment and Action Plan by email for review during the meeting.

A review of Permitted Emissions Points was carried out during the site walk around and no new points were identified.

Progress was also being made in converting gas boilers to electric to reduce GHG emissions with the specifications of the installed and proposed boilers forwarded to NRW.

Overall externally Permitted areas on site appeared in good condition at inspection.
