

## APPLICATION TO TRANSFER A MARINE LICENCE

Requests to transfer a marine licence from one licence holder to another that are made in writing to the Permitting Service will be charged a fixed fee of **£480**.

You will need to pay the fee upfront on submission of the transfer request.

The associated fee for transfer applications should be paid alongside the submission of this form, payments can be made via Cheque, BACS or credit/debit card.

- Cheques should be crossed and made payable to **Natural Resources Wales**.
- For BACS payments ensure you provide the reference number (not remittance number).
- For credit/debit card payments please complete the CC1 form and submit with the form. The CC1 form can be found on our web pages.

It is only possible to transfer whole marine licences. They cannot be split to transfer parts to separate operators.

Please be aware that our service levels for a transfer of a licence is 21 days from the date of receiving a completed application.
