This CAR report is issued to record NRW comments in relation to CQA reports submitted by the operator.

CQA validation report May 2025

As mentioned on previous CAR reports, the operator has been working to replace perimeter monitoring boreholes.

On 14/05/2025, the operator submitted a CQA validation report.

NRW reviewed this document and had the following comments;

"Egniol CQA Report Perimeter Monitoring Boreholes Replacement Works (*Ref 1269-ECL-XX-XX-RP-C-0001, May 2025*) which is satisfactory. The issues identified in Section 6.0, along with Section 7.0 conclusions of the report are noted".

CQA plan July 2025

The CQA validation report mentioned above, noted issues with borehole BH3AR. A CQA plan (reference 10269-ECL-XX-XX-SP-C-0002) was submitted on 10/07/2025 for the decommissioning of this borehole.

NRW reviewed this document and had the following comments;

"CQA Plan ref 10269-ECL-XX-XX-SP-C-0002 dated July 25 for decommissioning BH3AR is satisfactory and can be accepted.

One comment in relation to section 5.3.7. Due to the artesian pressure in the well, the contractor may need to provide some form of temporary over pumping until the concrete or cement has had a chance to set".

On 21/07/2025, NRW had notification that drilling and installation works for BH3AR1 and LMP had been completed. NRW is now awaiting the final CQA validation report from site.

ACTION: Submit final CQA validation report for outstanding borehole BH3AR by Wednesday 20th August 2025.
