4. Details of our assessment

This Compliance Assessment Report (CAR) is an assessment of the monitoring submission covering the Quarter 2 (Q2) (April to June 2025) period required by the permit of the operator, Cwm Environmental Limited - Nantycaws HCl Waste Transfer & Treatment Facility.

The Q2 monitoring submission was received within the reporting deadline specified by this EPR permit. This represents compliance with the environmental permit under permit condition 4.2.

From a review of the data submitted, Bioaerosol monitoring was undertaken and results reported were compliant with the stipulated emission limits required by permit condition 3 Emissions and monitoring. Surface water monitoring was also undertaken which represents compliance with the environmental permit under permit condition 3.5.1.
