4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised following a pre-arranged site inspection.

The site provided an update on improvements made to the site. Approval has been gained to install five silencers on all safety release valves, following a noise issue when a safety release valve was discharged.

Future projects were discussed which would involve changes to the installation and removal of some of the emission points. Advice was provided on the permit variation process.

Several process improvements have been made to the ETP following issues with suspended solids and a detailed presentation was provided prior to the site inspection.

Updates on investigations into the phosphorus issue were discussed but no clear plan has been implemented as yet. The site is waiting to see if the changes they have made to the ETP following the suspended solids breach will have an effect on the annual phosphorus limit before making any further changes to the ETP process.

The new dosing system on the Effluent Treatment Plant (ETP) was installed and commissioned at the end of April 2025 and this was viewed during the site inspection. Chemical dosing is now automatically controlled and linked to the main paper machine control system. The dosing system will eventually link with effluent flows in the future. To ensure greater control of the process the site has added another storage tank (grey whale) alongside the buffer tank to improve mixing and reduce peak loading to the ETP.

The site was able to demonstrate progress on their climate change risk assessment which is due to be submitted by 1st April 2026.

Discussions were also held on the 4 yearly reviews that are required by the permit for energy efficiency, efficient use of raw materials and avoidance, recovery and disposal of wastes produced by the activities.

The site was clean and tidy with no issues identified.
