Conditions 2.2 could not be audited as the site was not entered due to concerns with biosecurity especially Avian Influenza, this audit was carried out from the farmhouse and paper based, but i am confident that the process have not changed as per condition 2.1 Permitted activities.

You will be happy to hear that no non compliances were identified on our visit of the conditions audited.
