4. Details of our assessment

Monitoring data

Q1 and Q2 data received and reviewed.

Surface water

No non-compliances for set determinands.

During the review period, the site remains unmanned and as such daily meter readings have not been possible. Therefore compliance with daily volume and rate of discharge cannot be made. From the quarterly data the discharge volume is variable, with averaged values. In accordance with previous CARs this is considered a minor non-compliance.

The operator is progressing provision for automatic monitoring and recording of discharge volume, please provide a further update.

Groundwater

No non-compliances of permit limits in either PZ07/08R or PZ08/08R during the reporting period.

Landfill Gas

The methane permit limit was not exceeded in any monitoring location, refer to previous reports with commentary on carbon dioxide exceedances.

FID walkover survey conducted in April, no flammable gas was detected at any location across the site during either FID survey ~0ppm at all locations.

Actions - 1) Please continue to ensure that remaining in-waste boreholes are clearly marked, or that staff and contractors are made aware of their location, and 2) for both in-waste and perimeter boreholes, the headworks are maintained to allow representative samples of gas to be collected.

Schedule 6 Notifications were also received for the above breaches.
