We have reviewed the Construction Quality Assurance (CQA) plan document reference- *HAFOD QUARRY LANDFILL CELL 5c CQA PLAN Version 1.0 June 2025*- and associated documentation related to the construction of the new cell (Cell 5c) at Hafod Landfill that was sent to NRW on 23/06/25.

On 17/07/25, we informed the operator that we needed more time to review the CQA and associated documentation.

We are satisfied with the CQA plan and have no objections to the operator proceeding with construction.
