4. Details of our assessment

WARNING - non-compliance

On 1st August 2025 a routine inspection was carried out to assess compliance with permit conditions. On this occasion you were non-compliant. This CAR contains a warning.

Condition 1 - Management. 1.1.1 The operator shall manage and operate the activity: (a) in accordance with a written management system that identifies and minimises risks of pollution so far as is reasonably practicable, including those risks arising from operations, maintenance, accidents, incidents, non-conformances and those drawn to the attention of the operator as a result of complaints....

Breach of condition 1:

- On arrival at the site the filter arms were not rotating. It transpired that the siphon was blocked. Once released the effluent flowed as expected, to the filter arms which then rotated freely. **Maintenance is required to ensure this issue does not re-occur.**
- The concrete chamber wall is cracked in more than one location allowing untreated effluent to leak onto the ground. This could potentially pollute groundwater. **Maintenance is required to prevent leakages.**

Please ensure actions are completed by 29th August 2025.

Other advisory actions:

Please ensure safe access to the discharge point is available at all times.

Notes:

- As the flow to this site is low, effluent is recirculated through the works to ensure the filter bed does not dry out.
- Excessive scum was evident passing over the weir
- There is an automatic pump which pumps effluent from the outlet of the filter bed to a settlement system, which then discharges to the permitted outlet. This is to ensure compliance with suspended solids limit.
