Waste Regulation Officer Gareth Morris accompanied by Waste Regulation Officers Dan Hopkin and Marc Campbell visited Sims Group UK Limited, Sims Tremorfa, Unit 6, Martin Road, Tremorfa Industrial Estate, Cardiff, CF24 5SD on 06/08/2025 to conduct a routine site inspection and to assess compliance with environmental permit: EPR/AB3999ZF.

The operator holds a Tier Three Bespoke Permit for hazardous and non-hazardous mixed metal waste treatment and vehicle depollution facility

Weather on day of inspection, was clear, dry with little wind.

### Report Findings

On arrival at the permitted site, it was apparent that there has been no activity on the permitted site recently and that the site is currently non-operational.

Due to the site being non -operational there are no permit conditions to assess against and therefore no permit actions or breaches to be recorded.
