4. Details of our assessment**Huntsman Corporation UK Limited**

Huntsman Corporation UK limited operates in accordance with EPR/BV4223IE

Huntsman operates a specialist organic chemical plant with a capacity of 37,000 tonnes per annum, located on the site of former Bynea Steel Works, running along the Eastern and North-eastern boundaries is the river Loughor.

Purpose of Compliance Assessment

The following monitoring returns and report have been assessed within this Compliance Assessment Report (CAR):

- Quarter 2 (Q2): April - June 2025 Point Source Emissions to Water (W1)
- Bi- Annual 1: January - June 2025 Monitoring Returns, Emissions to Air

Compliance Assessment

Monitoring returns submitted to NRW via email on 6th August 2024, falls outside the specified reporting period as stated in permit condition 4.2.3.

Operator submitted a Schedule 5 notification to NRW on the 25th July 2025. Notifying that monitoring submissions would be submitted outside the required reporting period, due to error at the emission monitoring contractor's laboratory.

Dioxin/PCB sample (originally sampled WC 23rd June) had been lost and therefore unable to be analysed, the parameter required retesting.

Operator was notified of the lost sample on the 25th July, retest was rescheduled for the 29th July. The delayed monitoring submission was unforeseen and not at the error of the operator.

Q2 Point Source emissions to Water: W1

Operator has submitted the relevant results for all quarterly parameters requiring monitoring over this period. Monitoring results are compliant, with no breaches of the emission limit values (ELV) stated in table S3.2 of the environmental permit.

Biannual 1: January – June 2025 Monitoring Submission, Emissions to Air

Operator submitted the relevant results for all biannually monitored parameters for both A1 and A2. Periodic monitoring results have been assessed and are compliant with emission

limits stated in Table S3.1 with no breaches noted.
