This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

Natural Resources Wales is varying the permit to remove the Part B conditions from the permit. The permit is for a Section 1.1 Part B permit through aggregation of two or more units less than 20 MWth. Under paragraph 1(2) of schedule 8 of the Environmental Permitting Regulations 2016, sites that are Part B solely through aggregation are only subject to paragraph 4(1)(a) of schedule 8. Therefore we have removed the Part B conditions from the permit as these are not required for this type of activity.

Natural Resources Wales has also changed the permit number for Pentref y Groes from PAN-005837 to EPR/DB3499FD.

All references to PAN-005837 in the permit and variations shall be replaced by EPR/DB3499FD.

This variation does not change any of the permit conditions or limits.
