4. Details of our assessment

Dear Dwr Cymru Cyf.,

Permit Compliance Inspection at this site today, 11th August 2025.

Dwr Cymru Cyf. staff noted that the signal to the installed cello is very good now compared to how it used to be. The cello is above ground and attached by cable ties to a downpipe in the private garden.

Flow observed in the manhole was very small. The combined storm overflow outflow located by the watercourse was not operational and no evidence of sewage debris could be

seen in the vicinity. The line is desilted every two years.

It has been identified that the site name is incorrect on the permit, it should read "CSO at Bontnewydd Glanrafon No. 1" and not No. 10.

There were no non-compliances and no observations discovered during today's Permit Compliance Inspection site visit.
