4. Details of our assessment

SITE INSPECTION - GENERAL MANAGEMENT, PEST CONTROL AND FEEDSTOCK CONTAINMENT

11 August 2025

An un-announced site inspection was undertaken on the above date at approximately 10:45hrs. to ascertain the efficacy of recent pest (bird) control measures on site.

It was found that all of the agreed protocols are now in place. The netting was restored and no evidence of birds was present. See Photo 1 Below:

The concrete apron is now clean. Cleaning was taking place using a machine blade/loading shovel during the inspection, See Photo 2 below:

Front end scourers have been acquired, both hand steered and machine attached as in Photo 3, below to keep the concrete apron clear of feedstock and debris:

The EMS covers the management and cleaning protocols for feedstock on site and this must be followed as a minimum to maintain control and avoid any potential future incidents.

The agreed protocols, which should now form part of the management system are now being followed and the site is fully compliant with these aspects of the permit.

Please note that the EMS requires a regular apron and feedstock cleaning protocol and an avoidance of waste. Please ensure the requirements of the site EMS are expedited in full.

The main plant and equipment storage area is now clean of debris and litter and all equipment and hard standing is stored in an acceptable way. No litter was noted on the site or at the site boundary. As in Photo 4 below
