4. Details of our assessment

Dear Dwr Cymru Cyf.

Permit Compliance Inspection took place at this site today, 11th August 2025.

The site is owned by Gwynedd Council. Site access was acceptable today as the extreme overgrowth has been cut very recently. The overgrowth has to be cut approximately 3 or 4 times a year to ensure accessibility to the CSO as there is no footpath.

Spill height has been raised to reduce number of spills and "WILKS" screen installed approximately 18 months ago.

New CSO covers, cross barriers and locks were installed approximately 5 years ago to stop unauthorised persons accessing the CSO.

Dwr Cymru Cyf. staff verbally explained that their contractors access the site to undertake plant maintenance every 3 months - paperwork were not seen to verify this.

There were no non-compliances and no observations discovered during today's Permit Compliance Inspection site visit.

Thanks goes out to Dwr Cymru Cyf staff that attended and assisted during this site visit.
