4. Details of our assessment

This Compliance Assessment Report follows a prearranged visit to ICTs Deeside Paper Mill. Officers met with the Health, Safety and Environment Lead, Energy Manager, Mill Director and Construction Project Manager.

There has been significant progress in the construction of the facility since the last inspection and Officers walked around the site to see the progress. It is anticipated that commissioning of the mill and effluent treatment plant will commence towards the end of 2025.

Pre Operational (PO) Conditions

The Operator is reminded that a further update to the commissioning plan is required to be submitted to NRW in accordance with PO1.

A discussion was held in relation to PO4 - noise. The noise impact assessment (NIA) submitted as part of the permit application states that at Receptor C there will be a “*Minimum 2.5m tall acoustic barrier along the full boundary extent with the Welsh Government road*” and this has been used as a mitigation measure in the NIA. The acoustic barrier that is currently installed along the Welsh Government Road relates to Receptor B; however, the barrier linked to Receptor C, to the south of the site, is yet to be constructed. PO4 cannot be discharged if the mitigation measures identified in the NIA submitted as part of the permit application have not been installed in line with those used in the NIA modelling.

Further dialogue has since been had with the Operator regarding this PO. The Operator is reminded that Mill operations cannot commence until all the POs have been discharged.
