4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) to comment upon Q2 Monitoring Returns.

Q2 Monitoring Returns.

Q2 2025 (April – June) monitoring results were submitted to NRW on 25 July 2025 in accordance with Condition 4.2.3.

Emission Point A1.

Continuous air emissions monitoring (CEMS) was undertaken in accordance with Condition 3.2.

No Half Hourly or Daily Average Environmental Limit Values (ELVs) for Hydrogen Chloride, Ammonia, Oxides of Nitrogen, Sulphur Dioxide, Total Organic Carbon (TOC), Nitrous Oxide and Particulates were exceeded during Q2.

Emissions to air (Emission Point A1) for Carbon Monoxide show no 10 minute (ELV 95th percentile) or Daily Average ELV exceedances in accordance with Condition 3.2.1.

Stack emissions monitoring was undertaken in accordance with Condition 3.6.1 during April 2025. All results were below the ELVs. The Operator reported the following anomalies:

- 1st June, the 10-minute (15:10 to 15:19) from and half-hourly daily (from 18:10 to 18:29) CO figures are invalid due to communication issues with the CEMS PC during an update attempt.
- 28th May, the 10-minute daily CO figure at 11:26 has been invalidated due to both analysers entering an alarm state.

Daily averages were not available whilst the plant was off line for the annual outage from 10 to 29 June.

Residues.

Residues Bottom Ash and Air Pollution Control residues sampling was undertaken in accordance with Condition 3.6.1. Bottom Ash composition for Q2 remained below the 3% TOC limit at 1.43% in accordance with Table S3.4 of the Permit.

Plant operating hours year to date; 1,680 hours were recorded with no periods of abnormal operations.

Waste Returns.

Waste returns have been provided for Q2 as follows:

- Waste Received Q2 – 45,377 tonnes.
- Waste Removed Q2 – 11,616 tonnes.

Actions.

A written proposal for the management of the park and sanitary waste is still to be submit to NRW for review (Action 1 CAR NRW0048381 June 2025). A date for the completion of this action was not specified, however as previously advised changes to the waste management arrangements must not be implemented without written approval from NRW.

An action raised in the Q1 return 2025 CAR (NRW0046683) required the provision of the finding of an investigation into a TOC breach and the associated mitigation. A Part B notification was provided on 11 June 2025, which confirmed the cause of the breach was the over feeding of waste during unstable combustion conditions.

Measures have been implemented, including a new interlock system which means the feeders will now go into alarm and stop after 15 minutes if the required furnace temperature is still not being met.
