4. Details of our assessment

2025 Q2 Monitoring Reports

Cabot submitted forms A3 and W1 for Q2 2025 on 30th July 2025.

Emissions to air of Chloromethanes and Hydrogen Chloride from emission point A1 are all compliant with the permit limits.

Cabot advised NRW by email on 22nd July 2025 that sampling for Chlorine had taken place in April 2025 with the report received on 22nd May 2025 along with notification that there had been an issue at the lab with the Chlorine testing. The instrument used for testing was seeing interference at the Chlorine peak by Acetate or Fluorine, neither of which can be found through the sites process, and because of this no result was able to be reported. This ELV has not been exceeded since additional controls were implemented in 2010. As monitoring has been undertaken and evidence has been provided to assure NRW that every effort has been taken to obtain the result for Chlorine, no further action will be taken at this time.

Emissions to water at emissions points W1, W2 and W3 are all compliant with the permit limits.
