4. Details of our assessment

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.

On the 12/08/2025 a Natural Resources Wales (NRW) officer carried out a routine unannounced inspection of the hydroelectric power (HEP) scheme on Nant y Pantiau.

The licence holder was spoken with before the officer carried out the inspection unaccompanied. The visit was undertaken to assess compliance of the HEP scheme in relation the abstraction licence MD/054/0001/023.

The weather was hot and dry, and there had been very little rain in 4 months preceding the inspection.

The by-pass flow appeared to be working correctly and owing to the dry weather and low flows the facility was not abstracting water. The intake screen was obscured with debris and could benefit from cleaning before we enter the autumn weather to ensure that the system makes efficient use of the natural resource. The apertures in the intake screen were compliant with the licence requirements.

The hydroelectric generator for this permit is shared with an adjacent licence MD/054/0001/033 inspected separately, therefore the following is the same requirement as that listed in another compliance report. It was not possible to look into the discharge pipe, but there was no obvious fish screen which will need fitting as per the licence condition 9.5 (i).

In carrying out general maintenance please remember that material removed from above the impoundment structure should be returned to the watercourse immediately below the structure to enable natural sediment movement to occur.
