4. Details of our assessment

This visit is a follow-up to the previous site audit when some issues were identified and the works was in its previous old form before major rebuilding and investment improvements. All previous issues had been resolved to the auditor's satisfaction.

Spill limit to storm at the inlet weir is 4.4l/s but flows passed forwards to full treatment is around 6. This means the works is able to treat far more influent and spill less frequently.

DCWW visited Spittal school's sewage pumping station (operated by Pembrokeshire County Council) after shock-loads of septic effluent had been reaching the works and

compromising treatment efficacy. Changing its frequency of pumping has resolved this problem.

Desludging performance of the site is now better, which has reduced organic loading on the front end of rotating bio-contactor (RBC).

Alkalinity adjustment and ferric dosing are now in place to reduce phosphate levels to well below the permitted limits. There was a delay in getting ferric dosing into the revised permit, and this contributed to problems bedding in the performance of the new treatment regime because different stages of the process are tightly inter-linked and rely on one another. For example, one issue was commissioning the sand filter and its feeder pump, plus the suspended solids alarm on the feed to the sand filter.

DCWW is trying to bring forward the expected 2030 permit compliance before that year arrives.

- Temperature: 20 deg C
- NH3-N: 0.14mg/l
- P-PO4: 0.12mg/l
- Iron (Fe): 0.39mg/l
