This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q2 (April - June 2025) monitoring returns by Mekatek Ltd (the operator) for activities undertaken at Amex Park, Llansteffan Road, Johnstown, Carmarthen SA31 3NF under permit EPR-YP3937SH.

Q2 2025 Monitoring Returns

Releases to water - *Water1*

The operator submitted the **Q2** (1 April - 30 June 2025) returns for sampling and analysis of emissions to water (excluding sewer) at monitoring point **W1** to NRW on 25 July 2025.

- Monitoring was carried out within the Q2 monitoring period, in compliance with permit condition 3.5.1.
- Monitoring data was submitted within the Q2 reporting timeframe, using the forms specified in Schedule 4, Table S4.4, in compliance with permit condition 4.2.3.
- Based on the information provided, all other emissions recorded at monitoring point **W1** during Q2 appear to be compliant with the specified limits.
