4. Details of our assessment

This Compliance Assessment Report (CAR) is an assessment of the monitoring submission covering the Quarter 1 (Q1) (January to March 2025) and Quarter 2 (Q2) (April to June 2025) period required by the permit of the operator, Enovert South Limited - Tir John Landfill.

Emissions to Air

Q1 and Q2 quarterly monitoring

From a review of the information submitted, quarterly gas monitoring was undertaken for Nitrogen Oxides and Carbon monoxide, and the reported results were compliant with the stipulated emission limit required by permit condition 3 Emissions and monitoring.

The Total Bulk Gas Flow (m3/hr) data has not been submitted.

This represents a non-compliance of permit condition 4.2.2 - Reporting.

A consolidated non-compliance score of C3 has been allocated to this permit breach (covering the Q1 and Q2 monitoring period under compliance criteria (IR4B) Reporting.

Action - Ensure all monitoring and reporting requirements are completed and submitted in line with the EPR permit.

Annual reporting

The Annual reporting requirements for the Annual production under Table S4.2 of the Gas Utilisation Plant EPR permit was partly submitted to NRW under the "Tir John (Phase 1) Landfill - Annual Monitoring Review January - December 2024).

Please note: Tir John (Phase 1) and Tir John (Phase 2) are separate EPR permits and therefore the information should be submitted separately under the correct permit number for the Gas Utilisation Plant permit number EPR/BP3738LS.

This represents a non-compliance of permit condition 4.2.2.

An advisory has been allocated to this permit breach under compliance criteria (IR4B) Reporting. Please note going forward, subsequent CAR forms will be scored accordingly.
