4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q2 (April - June) 2025 monitoring returns by Dunbia (UK) (the operator) for activities at Teify Park Abattoir and Meat Processing Plant, Lampeter Road, Llanybydder SA40 9QE under environmental permit EPR-BV9683IH.

Q2 2025 Monitoring Returns

Emissions to water – Q2 Water

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to emission point W2 for Q2 2025 (1 April - 30 June) were submitted to NRW on 1 July 2025.

The parameter listed for emissions to W2 were:

(i) Total suspended solids, (ii) pH, (iii) BOD, (iv) Ammonia, and (v) Volume/Flow rate.

- The monitoring data was sent within the Q2 reporting period, which is compliant with permit condition 4.2.3.
- The monitoring was conducted inside the Q2 monitoring period, which is compliant with permit condition 3.6.1.
- The monitoring returns submitted includes reporting of monitoring carried out in respect of the parameters and emission points specified in table S4.1 of schedule 4, which is compliant with the environmental permit.
- Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified limits over the Q2 2025 reporting period.

Quarterly Waste Effluent Inputs to ETP - Form 4.2.5

This document was submitted to NRW on 1 July 2025.

- This data was sent within the reporting period, which is compliant with permit condition 4.2.5.
- The report details a NIL return.
